## **Pricing Schedule**

The following provides you with an overview of the prices applicable during calendar year 2021 for the services offered by and managed through VIRIDAD.

## **VIRIDAD Taxonomy Tool:**

As long as the VIRIDAD Taxonomy Tool is still in beta version and under development, we offer its usage free of charge. We expect to finalise development during the first quarter of 2021. As of then, for making use of the final VIRIDAD Taxonomy Tool, an annual subscription possibility will exist. It is limited to one user and costs 179€ (excl. taxes)/user/year. #### Taxonomy Quick-Check:

After receiving a sufficient level of information and documentation a Taxonomy Quick-Check will be performed within 3 working days. The deliverable will be a standardized high-level report on the likely eligibility of the assessed undertaking. It is provided by VIRIDAD, implemented by OMNIA GmbH at a standardized one-off price of 3,000€, excl. taxes.

Clients with a continuous need for Taxonomy Quick-Check are offered package deals (to be used within in a period of two years with upfront payment and without refunding):
